*** SPCH 1321 does not have an equivalent course at UH but will transfer and is the preferred course to meet the Business Field of Study Speech requirement (COM 1FOS). SPCH 1311 is allowed with appropriate content only: 50% more on preparation and presentation of professional speeches (requires petition and syllabus). SPCH 1321 or 1315 (or 1311 with approved petition) will waive with substitution COMM 3356 or MARK 3337, a required course for the BBA.
